I, the Participant, understand that my participating in the Event exposes me to the risk of injury or death due to a variety of hazards, including but not limited to (a) motor vehicles being operated on or around the roads where I will be walking or running, (b) my acts or omissions or those of fellow participants, volunteers, organizers, motorists, or others, (c) first aid or medical services rendered in connection with an emergency, and (d) the physical, athletic nature of the Event.

2. I understand that the Event is an athletic event that should be engaged in only by those who are physically fit and in good health, as determined by a physician. I realize that it's up to me or my doctor, and not the Circle Lake Association, to determine whether I am in good enough shape to participate.

3. I hereby release, forever discharge, and hold harmless Circle Lake Association from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that arise or may later arise during or in connection with the Event, including but not limited to liability, claims, or demands relating to any of the hazards noted above. THIS RELEASE APPLIES EVEN IF CIRCLE LAKE ASSOCIATION IS NEGLIGENT, GROSSLY NEGLIGENT, OR RECKLESS.

4. I hereby give Circle Lake Association permission to use any photos, images, videos, or other recordings of me or my likeness in conjunction with the Event, for any purpose whatsoever, with no compensation to me.

5. I agree that this release shall be interpreted in accordance with Minnesota law and that the Minnesota state courts located in Rice County, Minnesota shall have exclusive jurisdiction over any legal matters relating in any way to my participation in the Event.

6. I intend this release to be as broad as is permitted under Minnesota law. I agree that if any provision, sentence, or clause of this release is deemed invalid, the rest of the release shall still be enforced to the fullest extent permitted by law.
